At the Planning Commission meeting Kathy read the NEMCOG proposal to update Tri-township master plan. Betsy is researching park signage language. Kathy presented proposal from NEMCOG to update the Recreation Master Plan which must be on file with DNR by March 30, 2016, which expired December 31, 2014. The PC will hold the public hearing.

Z.A. report: Land Division on Swede Road, clean up is done on Mt. Maria Road, there has been more complaints about Sunrise Sanitation. Nancy will go out to see him again.

<u>Citizen Comments:</u> Kelly Barbatos, with land division, platted 50' lots, will leave one lot non-conforming. They will need to go to ZBA with a variance request.

<u>Park report:</u> This week the well is going in. Hope to have entire project completed by August 31<sup>st</sup>. On Sept. 17-20, there will be a Bass Tournament with launching at the Northend Park.

<u>Unfinished Business:</u> Mr. Ringer next to road easement on Caledonia Street has Senator Stamas coming to his place on August 20<sup>th</sup> at 11 am. Two members from the board will attend.

<u>New Business:</u> It is a consensus of the board that we remove the blinker light in Spruce. It would have to have maintenance done on it and the road commission feels there isn't enough traffic flow to warrant it.

Motion Scott, seconded Thornton to contract with NEMCOG for Recreation Plan preparation for \$3,045.00, in fiscal year 2015 with monies to come from the Public Improvement. Carried.

Sunrise Sanitation needs to be revisited and the board has authorized Z.A. Beck to start with a civil infraction Verizon-(Rob Smith) looking for tower sites and have looked at Hickey Hill. If they are interested there is a tower within 3 miles, so they would have to have a variance. They would need approval from the board, then go to PC for variance.

Motion Scott, seconded Thornton to appoint Ken Hubbard supervisor effective Sept. 1, 2015. Carried. Motion Timm, seconded Scott to appoint Travis Swinson to fill vacant position of trustee effective Sept. 1, 2015. C.
