<u>Z.A. report:</u> Nancy sent letter for blight issue on Mt. Maria Rd. No response yet. Attorney Harger feels the steps at the easement on Caledonia Street were grandfathered and should not have been removed without permission.

<u>Citizen Comments:</u> Tom Jacobs commented that pulling out of Bear Springs at Hubert Rd. is very hazardous to see with all the vehicles parked on the corner. Dennis Lamb - Caledonia Street has a vacant house that is a blight issue.

<u>ZBA:</u> Reviewed by-laws that were rewritten by the Planning Commission. Board felt having the common format between the PC by-laws and the ZBA by-laws was a good idea. After discussion on this matter it was decided that the modified by-laws will be adopted with the note that the ZBA will make any needed changes going forward.

Park report: This week sidewalks are being worked on and the project looks like it will be completed by the end of July.

<u>Unfinished Business:</u> Alpena Glass will order and install new entrance door in about six weeks. We will ask our attorney if the steps on Caledonia Street easement can be put back in. The board feels that being the easement property is owned by the county as a road end, concerned people should be in contact with the Road Commission. We will check with custodian to see about purchasing doggie bag dispenser to be installed at park, which was already approved.

<u>New Business:</u> Spoke with Joy Bullis, chairman for Hubbard Lake Triathlon, to be held August 1. Board agreed they may use the Northend Park, but not exclusively. The park should not be closed at anytime, but remain open to the public.

Motion Scott, seconded Hubbard to pay additional \$2,323.00 for gravel on Cedar Drive. Carried.

Motion Scott, seconded Hubbard to send 7 Pl. Cm. members and ZA to MTA Workshop, 8/26 in Lewiston, at a cost of \$81/person, plus per diem and mileage. Carried.

Supervisor Ron Ott submitted his resignation from the township, due to moving out of the township.

Motion Thornton, seconded Timm to accept Supervisor's resignation with regrets effective August 31, 2015. C. Position will be advertised and interviews for interested people will be held August 6, starting at 5 pm.
