Vichunas stated that in view of recent court decisions and further clarifications from the State, the draft Ordinance will be revisited.

## **NEW BUSINESS:**

**Right to Farm Act** – To comply with this Act, Freigruber stated that a proposed revision should be developed regarding 10 acre parcels and restrictions on horses. Freigruber further added that language regarding Ethanol production be included in the revision.

Master Plan Review – At the June 22, 2011, Tri-Township Planning Commission meeting, it was decided that each Township would review the checklist to determine the extent of revisions for discussion at the October 27, 2011 meeting. The five (5) year requirement for updating will be reviewed by Vichunas. She further stated that she will pursue a change of date from October 27 to October 26, 2011.
