Planning Commission: K. Vichunas finished writing Master Recreation Plan. They are working on Outdoor and Open Burning Ordinance, and Condo Ordinance. Their board is asking the township board to adopt the Sexually Oriented Businesses Ordinance. Next Tri Township meeting is June 24 hosted by Caledonia. Zoning Administrator report: Beck did a follow up at Borowski's on Hubert Road.

Citizen comments: R. Whiting questioned if wood burners were covered in Outdoor and Open Burning Ordinance. He was told we already have a Wood Burning Ordinance for stoves and boilers, but it was noted we should put that cross reference in the proposed Outdoor ordinance. He also had some questions concerning campfires and was told in the near future there will be a public hearing for the proposed ordinance. H. Friegruber had questions concerning mileage pay for Tri Township meetings; the township pays for mileage outside the township but encourages car pooling.

The public hearing for the Master Recreation Plan was opened with some discussion.

Northend report: Scott Engineering recommends we go for the larger grant (Waterways) right away, then if we qualify we will receive monies late fall and will be able to start work in the spring 2011.

Clerk had seven letters of interest for the custodial position. We narrowed it down to 5 of the candidates, and will hold a Special meeting, March 22, at 5:00 pm. Interviewing each person every 20 minutes.

Motion by resolution made by Timm, seconded Ott to adopt Caledonia Township general, road, and fire funds budgets for the fiscal year 2010-2011 as detailed in the budget package presented. 4 Ayes, 0 Nays, 1 Absent. Carried.

Motion by resolution Timm, seconded by Thornton to establish salaries for 2010-11 for Caledonia township employees, leaving them the same as the past two years. 4 Ayes, 0 Nays, 1 Absent. Carried.

Motion Timm, seconded Thornton that the township of Caledonia will levy the maximum authorized millage rate allowed by law for tax year 2010. 4 Ayes, 0 Nays, 1 Absent. Carried.

Motion Timm, seconded Ott that we sign contracts with Hubbard Lake Community Association (\$50,348) and Sanborn Township (\$2800.00) for fire protection for 2010-11. Carried.

Motion Timm, seconded Scott to have Stephenson, Gracik do audit for the years 2008-10. Carried.

Motion Thornton, seconded Scott to adopt Sexually Oriented Businesses Ordinance as presented. C.

Motion Ott, seconded Scott to pay J. Hahn for January Planning Commission meeting. Carried.

We are changing the April meeting date to April 28 in order to be sure and have a quorum present.

Motion Thornton, seconded Scott to adjourn at 8:45 p.m.
