Planning Commission: Discussion over just anyone at anytime from the township boards inspecting at residential properties. Suggestion was to set up appointments and/or ID badges. John and Jack are researching Medical Marijuana Dispensary language.

Zoning Administrator report: Measured M. Szor's fence. C. Burke cleaning up. J. Mace waiting for a commercial dumpster. C. Franzel asking about fence lines and ordinance regulations.

Ron Ott will speak with T. Swinson who is interested in filling the vacancy on ZBA board.

Thunder Bay Power-Scott Klabunde presented their case to allow public access to the dam by entering pathway from the township park. It was suggested that there be more than 2 parking spaces, one being handicap accessible, and Ott says if board does give access it should be of no cost to the township to build or maintain in the future. Thunder Bay will draw up an agreement and return to present it to the township. G. Grove spoke regarding the new Caledonia application form and concerns over just anyone at anytime coming around a residence. Beck, Zoning Administrator stated she has an ID badge and Ott will check into obtaining badges for ZBA members. Planning Commission will submit new wording for application-"access by appointment" and possibly "must present ID badge."

Basement floor joist jacks have been replaced. Motion to have Murphy builders fix closet door in hall, so it will close properly and lock, not to exceed \$150.00. Carried.

The board spent quite a bit of time holding discussion and review with Mark Staley about the Waterways grant for the Northend Park improvements. The total estimated cost of this project is approximately \$191,000.00 with the township's share being \$95,500.00. We discussed altering some of the plans to save money for the township, but others would like it to go ahead as planned. Our next step will be to hold a public hearing next month for more input. There will also be a write up about the park in the Alpena News asking for public feed back and inviting them to attend.
