Zoning Administrator report: C. Burke cleaned up front of his house. J. Mace no further effort made, will continue to monitor, Cellere-Verizon antenna on Hubert Road will be replacing the antennas on their unit-no changes in size or number of antennas.

Thunder Bay Power-Scott Klabunde presented "Parking Agreement" with township allowing an opening with gate, TBP to construct a surface parking lot consisting of six regular spaces and 2 handicapped spaces, TBP to pay annual maintenance fee of \$1500.00, which the township shall use to maintain parking lot and walkway in the future. The board asked for some alterations in agreement to refer to the "township" not the town, and to add the cost of a roadway to the parking area from our entrance drive.

Opened to the public for discussion on Waterways Grant between Caledonia Township and Michigan Department of Natural Resources (DNRE) for improvements at Northend Park the sum of \$190,934. The township's share is 50% of that. Many spoke in favor of the project. One person was opposed fearing the Northend park might fall into the DNR's hands. Also costs were discussed and suggestions for cutting back or trimming the plans in order to not spend as much.

Motion Brown, seconded Thornton that Caledonia Township accepts Waterways Grant in the amount of \$190,934.00 with township's paying 50% of that amount. Ayes-Brown, Thornton, Timm. Nays-Ott, Scott. Motion carried.

Ruth Hess questioned progress on clean up on Jack property; we'll let Nancy know to follow up. Motion Brown, seconded Ott to reappoint John Preston and Nick Williams to the Planning Commission for a three year term. Carried.

Custodian reported: that the Exceptional Friends are not cleaning very well after using the hall. Clerk has told Darlene to speak with them.
