Planning Commission: Vichunas e-mailed to the board proposed Medical Marijuana Ordinance for review and approval at July's meeting. Planning Commission would like to include this addition into the revised zoning ordinance. Zoning administrator has been asked to attend July meeting for clarification of the "Right to Farm Act". Jane Waldeck reported that nursing homes and assisted living facilities are considered a "use by right" or "special land use" in certain zoning districts. Therefore, no further research is needed for our ordinance. Vichunas will contact planning commission of Alcona Township and Hawes Township to reschedule the Tri-township meeting from June 23 to June 22, hosted by Caledonia Township. It is very dark in hall parking lot; Scott will get bids for motion flood lights for front of hall. The flag on stage is very faded, Vichunas will check with VFW for a new flag inside the hall.

Z.A. report: Beck still working at lowering Szor fence. Borowski and Mace are cleaning up. Checked on VFW hall possible sale pending.

Citizen comments: Read letter from My Lanskreener about the condition of Cedar Street and their wanting to improve the road.

Long discussion with a few Cedar Street residents and Ron Young from road commission. Young will look at costs for graveling and cleaning the ditches with possible work to be done late summer, early fall. Board denied their request for township payment towards a second chloride treatment on Cedar Street.

Ted Somers explained road commission puts markings on new road projects as they can afford them. He would like the township to consider paying 50 percent of road marking costs on future road projects.

Motion Brown seconded Thornton to adjourn at 8:02 p.m. Carried
