Motion Brown, seconded Thornton if and when the Spruce Post Office closes the township will allow USPS to install a CBU unit for P.O. box mail, only if it is not a greater cost to the township for liability insurance. The boxes will be placed in a location agreed upon by both parties and the installing cost would be the USPS responsibility. Clerk will call insurance company and check into this.

Henry Freigruber mentioned the illegal signs that are still up in the township. Nancy says that Rondeau is still in business thus his sign can remain up. Henry also said that Churchill Pointe sign on Dahl property is over the limit of three. Nancy said no that Churchill only has 3 signs in the township. But it was pointed out that the ordinance says 3 per property. The ordinance ruling will be checked into.
