Motion Thornton, seconded Scott that we sign contracts with Hubbard Lake Community Association (\$49,231) and Sanborn Township (\$2800.00) for fire protection during 2012-13. Carried Motion Brown, seconded Thornton to contract with Alcona County Humane Society (\$600) for animal control within the township. Carried.

Motion by resolution Thornton, seconded Ott to support Northend Park Phase II grant with maximum \$300,000 grant and township paying 25% up to \$75, 000, match. Vote 5 Aye, 0 Nay C. Motion Scott, seconded Ott that township board grant the Planning Commission 3 more study sessions (March 20, 27, & Apr. 5) to complete the ordinance revisions. Carried.

Township will keep hall deposit from Olsen wedding rental for loosing key to hall and our having to change the lock on the front door, when there was damage like a possible break in to upstairs door jam. Jack will find someone to repair door frame.

Motion by resolution Thornton, seconded Brown to adopt revised Poverty Exemption for 2012, one (Homestead) parcel of land not to exceed \$30,000 assessed value or market value \$60,000, and other assets not to exceed \$30,000. Vote 5 Aye, 0 Nay Carried.

Motion by resolution Timm, seconded Ott that Caledonia Township does hereby proclaim that May 2012 is Social Host Liability Awareness Month. We also call upon all citizens, homeowners, and

property owners to host gatherings responsibly and take measures to eliminate access of alcohol to persons under the age of 21. Vote 5 Aye, 0 Nay Carried. Motion Brown seconded Thornton to adjourn at 8:07 pm. Carried.
